There are 2 tasks planned, each day 1 Task. The tasks are determined on the basis of the daily weather conditions by the competition management immediately before the start. (race to goal, speedrun, buoys). The briefing is compulsory!

Conditions of participation

- Austrian Paragliding XC-license or XC-license according to the list of countries of the Austrian Guest Flight Rules

https://aeroclub.at/uploads/images/site/649/content4_text2/132a_Letter-to-foreign-countries_170321.pdf or a temporary certificate by the local flight training organization (*Austrian Guest Flying Permit*)

- valid FAI sport license
- airworthy flight equipment, according to the guidelines of the Austrian league. Paragliders class EN A-D u. CCC; helmet, rescue parachute and harness protector are required. A change of the glider during the competition is only permitted with the permission of the event manager. The paragliders must be flown in the certified configuration, the competition management can carry out a check at any time. Changes outside the certified configuration may result in disqualification.
- Aviation Liability Insurance coverage according to Austrian standards
- Completed and signed application form
- Participation in the briefings (compulsory attendance!)

Registration / selection

Mandatory registration via www.livetracking24.com . The selection after the order of registration and after payment of the entry fee will be done according WPRS-ranking. A subsequent registration is possible by free starting places on Saturday 13th april) 08:30h - 9:30h at competition office.

The **number of participants** is limited to 70 pilots. The organiser reserves the right to award 10 wildcards. 40 places are reserved for austrian pilots till 30th mars 2019. If number of max. participants is not reached, pilots will be selected according "first come - first serve"! A subsequent registration is possible by free starting places on Saturday (12th) 08:30h - 10:00h at competition office.

€ 62, - (or € 67, - for late registration on the day of the competition)

If the pilot does not appear, the entry fee will not be refunded.

Should the main and alternate dates be canceled, the entry fee will be reimbursed less an administration fee of € 5, -.

In the case of cancellation of a task the day before after price giving ceremony € 15, - will be refunded to the present pilots.

Services

The entry fee includes: the ONF competition fee, Waypointlist, retrieve transfer to the event site, scoring, prices

Liability

The organizer and also the land owner are not responsible for the pilots or third parties. Participation in the competition, transfer, retrieval shuttle and event program is at your own risk! The organiser refuses liability for accidents, material damage or theft to the pilots or third persons.

The participant agrees to follow the rules of the competition. Failure to do so will result in being disqualified from the event.

Cancellation of the competition

On the definitive execution of the competition will be no later than Friday the 12.04.2019 until 13:00 clock decided. Retrieval service

For the return each pilot is responsible! It is set up a retrieval center, which collects the pilots with buses on the main roads. Head Retrieve Service: will be soon announced

Feedback duty

Each participant must sign up (by signature) to the competition office by the time notified to the briefing. Telephone feedback is only accepted if the pilot is unable to report back to the competition office by the required time. Any unreported participants will be searched by all available means. The cost of the search will be charged to the participant.

Documentation and scoring

The documentation of the competition flights takes place exclusively by means of GPS and the scoring according to the league rules.

Upload by participants

The organizer provides free Wi-Fi in the competition office - participants should transmit their GPS tracklog electronically in good time (upload to server / send by e-mail).

Upload by organizer

For participants who cannot upload the GPS tracklog themselves, the organizer offers the possibility of a manual GPS download / scoring. This will be charged with € 5, -.

GPS cables for the most common devices are available, but it is recommended to bring along a suitable PC connection cable.

Protests

must be made no later than 30 minutes after notice of the intermediate or final result written and with simultaneous payment of the protest fee at the event management be introduced. Protest fee: € 50, -. Protests to the ONF according to the competition rules.

Prices

Prizes and cups.

Doping:

The organizer strictly rejects doping. Each participant agrees to comply with the Anti-Doping Regulations. Austrian sport law doping controls can be executed at any time.
